- Please **DO NOT** take pictures of other vendor’s products without their permission. You will be asked to leave the event.
- **VENDOR/CRAFTER SET UP TIME: 6:30 A.M. – 8:30 A.M. - NO EARLIER**
- Vendors/Crafters **MUST** stay until closing time of 2:00 P.M. and **MUST** clean their area at the end of the day.
- Handmade crafts only – no resales. This is **NOT** a yard sale!
- Duplicate brand vendors are not allowed (e.g., Scentsy, Paparazzi) – First Come, First Serve.
- All spaces are 8 ft. x 8 ft. - (limit 2 spaces per participant – we will provide each table with 2 chairs). Table size may vary. We have 6- and 8-foot tables.
- **Set-up (including loading in) and clean-up are your responsibility. If you need assistance, please plan to bring help with you. Each vendor may bring one person with them.**
- Please DO NOT intrude on your neighboring vendors.
- You must keep the aisles clear - **DO NOT MOVE THE TABLES FROM THEIR AREA.**
- Items that play loud music or any other noise are not permitted.
- Spaces are **NOT TRANSFERABLE** by vendors. If you find that you will not be able to attend after registering, you **MAY NOT** send another person/vendor to utilize your space and your payment will **NOT** be refunded. There will be **NO REFUNDS** for no one shows upon said day.
- Neither smoking nor vaping are permitted inside any part of the building.

Modern Maturity Center reserves the right to reassign or change a space if it becomes necessary. We also reserve the right to deny any space **WITHOUT** a refund to any exhibitor in violation of any of the rules.
